Chris proudly shares a story of a school construction project that his father was working on when the superintendent approached him [Larry] to discuss the timeline and whether they could speed up the project. The superintendent explained that not only did the school provide breakfast and lunch for the students, but many did not have

Each generation has put their mark on the community. A native of Manhattan, Benjamin Spraragen, came to Schenectady to attend Union College and graduated from the electrical engineering program in 1916. He started the business selling household supplies and hardware and doing light residential work. He later progressed the business and worked on converting gas lights to electric. His son, Donald served as CEO from 1982-93. Donald continued to grow the residential business and started to expand into light commercial work. In 1986, grandson Larry was appointed President. Larry had been an electrician in the Navy and at SHE,

running water at home and school was where they shower. "This opened my father's eyes to the needs of our community more than anything else he had done," said Chris. "That week he pulled all his workers from other jobs to complete the school project by Monday morning," Chris added.

Equally as important to the family is supporting of the region through leadership and volunteerism. "Next year marks our 95<sup>th</sup> anniversary and the best is yet to come. Our family was born and raised in this community and we will continue to support and invest in Schenectady," said Chris' mother Sheila Spraragen. EEllis has always been there for our family. Drs. Bradford and Judith Ruthberg are Radiologists who have each worked at Bellevue Women's Center, saving countless women's lives, for more than 30 years, only a few years less than they have been married. "We went to medical school at the University of Miami, and then did our residencies at Albany Med. Brad was hired first by Bellevue, in 1986. A year later, when I was offered a job there, I jumped at the chance," says Judith.

Tragically, in 2003, Brad's mother Helen, an artist, miniaturist, and author of renown, died of breast cancer. Her husband, Dr. Jack Ruthberg, started a fund at Ellis in her memory – The Helen R. Ruthberg Endowed Fund for the Earliest Possible Detection and Prevention of Cancer. Drs. Brad and Judith continue to contribute to the fund every year in memory of both Dr. Jack and Helen. "We know that early detection is still the best treatment we have. This fund helps Ellis purchase the latest radiology equipment and supports those who need cancer screening. We are pleased and proud to contribute to its continued growth," says Brad.

Thanks in part to the Helen R. Ruthberg Endowed Fund, in 2016 Ellis purchased a Breast Tomosynthesis, also known as 3D Mammography, that provides a clearer, more accurate view compared to digital mammography alone. This advanced type of mammography can offer improved
