# Construction Progresses on the new Center for Surgical & Interventional Medicine

Ellis is investing \$19.4 million to renovate and expand cardiac, vascular and interventional surgery with upgrades to technology, operating and procedure rooms and the pre- and post-care recovery areas. The jewel of the new Center for Surgical & Interventional Medicine will be a state-of-the-art hybrid operating room (OR) where a team of surgeons, interventionalists, nurses, anesthesiologists, and technicians will work seamlessly together—all to provide better quality of care and better medical outcomes for our community.



Dr. Robert Joy of Cardiology Associates of Schenectady and Chief of Cardiac Services at Ellis, is one of the physicians spearheading this project. With advances in technology, there are

more and more procedures that surgeons can partner with to deliver better care. "The hybrid OR allows us to offer the latest procedures to our patients and uphold our leadership position in cardiac care." said Joy. Currently, in some cases, patients have to be transferred from one location within the hospital to another, under anesthesia to complete those procedures. This is not ideal for the patient, the surgeons

# The Gift of Gratitude

When Werner Feibes fell off his roof in 2004, he landed in an alleyway next to his home in Schenectady's Stockade. He injured his entire left side so severely that he spent more than six weeks in the hospital, followed by two weeks of home care provided by the Visiting Nurse Service of Northeastern New York, or VNS for short.

Now, at the age of 87, Werner is fully recovered from his accident. When he first left the hospital, he was told that he could expect to never regain the full use of his leg and foot. "I'm happy to show that they were wrong," he says, as he rotates his foot. "I had a fantastic nurse from the VNS. She demonstrated what she wanted me to do, rather than telling me." Werner, an architect, is a visual learner. His nurse knew the perfect approach for working with him in the comfort and privacy of his own home, and he continues to be both amazed and grateful.

Werner was born in Germany in 1929. After the ascendancy of Nazi Germany, his family fled first to New York City and then to Schenectady, where they "could be American, rather than be immigrants in a neighborhood in New York City. Schenectady has always been very good to me – I am very proud to be a part of this community."

Now Werner wants to give back. He and his partner, Jim, collected art throughout their lives together – a collection that they are leaving to the Hyde Collection in Glens Falls. Werner also intends to leave another very meaningful gift: through a bequest in his will, he has designated a portion of his estate to support the VNS.

My experience with the Visiting Nurse Service was just extraordinary. My nurse gave me back my mobility. It's hard to put a price on that, but I hope my gift helps others as much as my nurse helped me.

#### **IRA** Rollover

If you are 70 ½ or older and are required to take a minimum IRA distribution, you can take advantage of a charitable rollover gift. Simply make an outright gift to The Foundation for Ellis Medicine from your IRA (gifts to all charities cannot exceed \$100,000 per taxpayer per year). Your rollover gift will not be included in your taxable income. Since an IRA is always subject to estate tax, by making a gift to Ellis from your IRA, you also will be removing taxable assets from your estate.
